

## **I&E Director**

**Job Summary:** The I&E Director will manage all instrumentation and electrical work for CAPEX projects. This exempt-level position will report directly to Engineering, but will work closely with IT, SCADA Developers, and Operations.

### **Responsibilities**

- Manage all electrical contractors, instrumentation and control contractors, and electrical skid manufacturers for all Capital projects.
- Lead, develop and manage in-house I&E/automation project managers.
- Manage all electrical aspects for SWD and RTU start-ups.
- Develop load sheets and secure utility power in a timely manner.
- Manage all temporary electrical equipment such as rental gensets, temporary pumps, fuel supplies, etc if early startup of facilities is required.
- Manage installation of field cameras and monitoring systems.
- Maintain project schedules, and ensure tasks are completed in a timely fashion.
- Develop drawings and specifications for turnkey bidding in order to construct an I&E system that adheres to company standards.
- Manage the I&E portion of assigned capital projects and track AFE's.
- Adhere to and promote company's safety policies.
- Verify I&E contractors and ensure they are staying in scope.
- Manage multiple construction project assignments simultaneously and meet deadlines.
- Ensure all safety, environmental and Company policies/procedures are communicated and enforced
- Manage and ensure work crews follow all customer, safety and environmental requirements.
- Build and maintain positive working relationships with customers, subcontractors, and vendors, at all times.
- Facilitate the development and ongoing update of company I&E standards.
- Other tasks and projects may be assigned, as needed.

### **Education and Experience:**

Electrical Engineering degree strongly preferred. Minimum of 10-15 years of project management experience is required, or equivalent combination of education and experience will be considered. Prior experience leading/managing internal teams is required. Previous industrial field electrician experience and industrial automation experience required. Prior experience managing contractors and vendors is needed for this role.

**Other Job Requirements:** Must have the ability and willingness to spend long hours in the field during critical activities. MS Office proficiency, project management software, and high level of comfort with computers and various productivity technology.

The candidate should be highly skilled in the following areas: project management, problem solving, task prioritization, active listening, verbal and written communication. This position requires a self-starter/self-learner that demonstrates clear accountability and can adapt easily whether working independently or with a team. The candidate must have a strong sense of urgency and sound judgment. Must possess a strong work ethic, ability to manage multiple projects and staff simultaneously and meet deadlines. This candidate must be able to work independently and make sound decisions.

## **I&E Director**

### Working Environment/Physical Requirements:

Must be able to regularly perform physical tasks such as entering a confined space, operating large valves, climbing stairs and ladders, and walking long distances. Outdoor work in all weather conditions. Must be able to frequently climb ladders, crawl, crouch and kneel occasionally. Frequent lifting required up to 50 lbs, with average lifting up to 25 lbs. Walking/pushing/pulling are also frequently required. Must be willing to work long hours, as needed, and have a flexible schedule to accommodate business needs.
